

Diagnostic Medical Sonography

The Diagnostic Medical Sonography (DMS) program's mission is to prepare competent entry-level sonographers who will provide exceptional patient care accomplished through high quality education in didactic, laboratory, and clinical instruction with emphasis on the cognitive, psychomotor, and affective learning domains.



Admission Criteria

Students will be admitted in the fall semester of each year. The AAS in DMS has a limited enrollment number and meeting the admission requirements does not guarantee admission.

Complete required general education courses with minimum grade of "C" or better.

These courses must be taken prior to beginning program courses.

- AH 200 Statistics*
- BI 151 Anatomy and Physiology I & Lab
- COM 100 Oral Communications
- ENG 100 English Composition
- PHY 100 Introductory Physics

These must be taken in semester indicated or other semester before completion of program.

- PSY 100 Psychology**

Individual course grades will be used as part of point system to rank applicants for admissions to the DMS program.



Admission Information

Qualified applicants for the DMS program are ranked using a point system from highest to lowest. Points are awarded based on the following criteria:

- Prerequisite grades in Anatomy & Physiology I, Physics course, and Math course with an "A" receiving 5 points, a "B" receiving 3 points, and a "C" receiving 1 point for each course. If courses are taken at Southeast Missouri Hospital College of Nursing & Health Sciences, then 1 additional point will be added to grade for that course.
- For applicants who provide transcript of degree and copy of current license/certification for eligible 2 or 4-year degree nursing or allied health profession, 5 points will be awarded. Applicants with approved transcript of health-related certificate or CNA certification are awarded 2 points toward admission to the DMS program.
- If two or more applicants have the same number of points, the ATI TEAS score will determine final ranking.

Applicants will be notified of contingent acceptance to the DMS program through email. Applicants not accepted may be placed on an alternate list for current admitting year only. Applicants not accepted to the DMS program should schedule an appointment with a Southeast Health College of Nursing & Health Sciences advisor to discuss other educational opportunities or continue course work for reapplication the next year. Applicants will be re-ranked each year for admission.

Other Information

Program Accreditation

Southeast Missouri Hospital College of Nursing & Health Sciences Diagnostic Medical Sonography program is currently seeking accreditation in Abdominal Sonography – Extended, Obstetrics and Gynecology Sonography, and Vascular Sonography concentrations by the Commission on Accreditation of Allied Health Education Programs (CAAHEP) upon the recommendation of the Joint Review Committee on Education in Diagnostic Medical Sonography (JRC-DMS). Once accredited, this status will allow DMS students to register with the American Registry of Diagnostic Medical Sonography (ARDMS) for the Registered Diagnostic Medical Sonographer (RMDS) specialty board examinations 60-days prior to graduation. Students will take the Sonography Principles and Instrumentation (SPI) during the summer semester of the program and until program accreditation is achieved, apply to take American Registry of Radiologic Technologists (ARRT) Sonography exams upon successful completion of the Associate of Applied Science degree in Diagnostic Medical Sonography.

Compliance for Registration and Clinical Rotations

The Diagnostic Medical Sonography program follows compliance policies for the ARDMS and ARRT regarding applicants for board exams through respective agencies and needs of clinical sites. Students are required to submit to background check and drug screening through Southeast Health College of Nursing & Health Sciences designated service provider. Information obtained from background check and drug screening could jeopardize a student's ability to participate in clinical experiences resulting in the inability of the student to complete the DMS program.

Application for certification examination with the American Registry of Diagnostic Medical Sonographers (ARDMS) and American Registry of Radiologic Technologists (ARRT) contains questions as to whether an applicant has ever been convicted of a misdemeanor or felony excluding minor traffic violations. ARDMS or ARRT may deny an application for certification based on answers to questions in the application. If a student has questions about their eligibility for certification, a pre-application process is available by the ARDMS or ARRT.

Program Goals

The goals of the Diagnostic Medical Sonography program include:

- To prepare competent entry-level sonographers in the cognitive (knowledge), psychomotor (skills), and affective (behavior) learning domains for the abdominal sonography-extended, obstetrics and gynecology and vascular sonography concentrations.
- Providing a comprehensive DMS program to produce competent and compassionate diagnostic medical sonographers to be part of a diverse health care team.
- Promoting lifelong learning within the profession of diagnostic medical sonography.
- Serving as a resource for ultrasound departments in Southeast Missouri.

Student Achievement Data

The first cohort of students began the program fall 2023 and outcome data for the DMS program retention, program completion, job placement, and board certification will be published as available.

Southeast Missouri Hospital College of Nursing & Health Sciences Diagnostic Medical Sonography program focuses on Abdominal Sonography – Extended, Obstetrics and Gynecology Sonography, and Vascular Sonography concentrations.

Students will be encouraged to take the Sonography Principles and Instrumentation (SPI) during the summer semester of the program, and apply to take American Registry of Radiologic Technologists (ARRT) Sonography exam upon successful completion of the Associate of Applied Science degree in Diagnostic Medical Sonography. Students will be encouraged to take American Registry for Diagnostic Medical Sonography (ARDMS) specialty board examinations based on examination requirements and prerequisites.
