

## Front-Line Staff Information for SBA Economic Injury Disaster Loan Program

- Governor Pritzker and DCEO have filed for a statewide Economic Injury Declaration with the U.S. Small Business Administration (SBA) in order to qualify Illinois small businesses impacted by the COVID-19 outbreak for federal Economic Injury Disaster loans.
- Once we have received the declaration, small businesses, small agricultural cooperatives, small aquaculture businesses and most private non-profit organizations in all 102 Illinois counties may be eligible for low-interest, economic injury disaster loans up to \$2M per business.
- Eligibility requirements are determined by SBA and can be found [here](#).
- Businesses can access additional information and apply for the loan online [here](#).
- These loans can provide relief to Illinois small businesses struggling to pay fixed debts, payroll, accounts payable, or other bills.
- DCEO expects to post links to the Illinois SBA online loan application very soon.
- Business advisors at our [Illinois Small Business Development Centers \(SBDCs\)](#) are available to assist small businesses with the loan application process and are currently operating remotely. - DCEO is working with federal and local partners, like yourselves, to ensure assistance will be available for small businesses seeking loans, counseling and preparedness planning.
