WADI MONTHLY UPDATE

WADI is busy adding participants to the new QUEST grant. The spring semester is going well with one parmacy tech student in training at SIC and this participant is also working at Beck's Drugs in Eldorado. One CDL student has obtained their license as well. Bonnie and Ryan T. attended the Jim Pott's training in Marion. This training is an excellent resource for eligibility and IWDS hands on experience. On March 8th, Ryan D and Ryan T will be attending the Harrisburg High School Job Fair to help spread the word about WIOA.

SDC MONTHLY UPDATE

SDC WIOA has enrolled 15 new participants for the spring semester and currently has a total of 36 enrolled in training services for the spring. They will be adding more truck drivers in March at SCC and SIC. SDC has 2 participants on the State Work Experience program and 1 on the Quest grant. Currently there is one in each of the following counties: Massac, Pope and Pulaski. They also have approximately 3 pending applications. In January & so far into February SDC has attended 2 webinars on the Quest grant and one on the State grant through Sol4 LWIB. Lisa Baker, the WEX Coordinator, attended WIOA training in Marion. DCEO monitors provided our monitoring visit on Feb. 13th. On March 18th the next Truck Driving class begins at SCC. There is an upcoming Job Fair at SCC on April 3rd that SDC plans to attend.

SOUTHERN 14 UPDATES

We are in the midst of the Regional and Local Plans that must be submitted every 4 years. This process has several steps but we are working with our partners and will be seeking board approval regarding our Local Plan at the next board meeting. The MOU is complete and ready for the Board to approve as well. We have submitted our Report of Outcomes and Draft Budget for review. Over the next two weeks we will host the Personnel, One Stop, Oversight, and Executive Committee meetings to be ready for our upcoming board meeting. Pam has been working diligently on several new Incumbent Worker Projects. In fact, we currently have 6 IWP occurring which is an excellent feat. In addition to those, we believe to add two more in the coming months. We have began enrolling participants in both the Quest and State Grants and are working closely with state officials to make sure we are completing all reporting and monitoring requirements.

Southern Illinois Highlights

Carbondale – Marion Area

The December 2023 unemployment rate was 4.2 percent. This was a +0.7 percentage point increase from the December 2022 rate of 3.5 percent. Total nonfarm employment increased by +800 jobs in December 2023 compared to December a year ago. Government payrolls increased over-the-year (+200).

Surrounding Counties

Total nonfarm payrolls increased by +400 jobs in December 2023 compared to a year ago.

Employment rose in Leisure and Hospitality (+250), Government (+200), Educational and Health Services (+75), Construction (+25), Financial Activities (+25) and Natural Resources and Mining (+25).

No change in employment was reported in the Information or Manufacturing industries.

Payrolls declined among employers in Trade, Transportation, and Utilities (-100), Professional and Business Services (-50) and Other Services (-25).

Harrisburg Area

Total nonfarm employment increased by +450 jobs in December 2023 compared to December 2022.

Employment gains were posted in Government (+175), Financial Activities (+100), Trade, Transportation, and Utilities (+50), Natural Resources and Mining (+50), Information (+50), Other Services (+25) and Educational and Health Services (+25).

No change was recorded in Leisure and Hospitality payrolls. Employment declined in Construction (-25), Manufacturing (-25) and Professional and Business Services (-25).

Olney - Mt. Carmel Area

Total nonfarm employment increased by +350 jobs in December 2023 compared to December 2022.

Payrolls increased in Government (+150), Trade, Transportation, and Utilities (+125), Educational and Health Services (+75), Leisure and Hospitality (+50), Other Services (+50), Natural Resources and Mining (+25), Information (+25) and Professional and Business Services (+25).

Payrolls were unchanged in Construction over-the-year. Payroll employment decreased in the Manufacturing (-100) and Financial Activities (-25) industries.
