Southern Illinois Highlights

Carbondale – Marion Area

The December 2022 unemployment rate was 3.7 percent. This was a decrease of -0.4 percentage point from the December 2021 rate of 4.1 percent. Total nonfarm employment in December 2022 increased by +500 compared to December a year ago. Employment increased in Government (+300).

Surrounding Counties

Total nonfarm employment increased by +450 compared to December 2021.

Employment gains were posted in Educational and Health Services (+175), Leisure and Hospitality (+175), Government (+150), Construction (+25), and Other Services (+25).

Financial Activities, Information, and Manufacturing payrolls were unchanged over the year.

December payrolls declined in Trade, Transportation, and Utilities (-50), Professional and Business Services (-25), and Natural Resources and Mining (-25).

Harrisburg Area

Total nonfarm employment increased by +125 compared to December 2021.

Employment gains were posted in Government (+150), Educational and Health Services (+50), Information (+50), Natural Resources and Mining (+25), and Other Services (+25).

Payrolls in Financial Activities, Leisure and Hospitality, and Manufacturing were unchanged. Employment declined in Construction (-100), and Trade, Transportation, and Utilities (-50), and Professional and Business Services (-25).

Olney – Mt. Carmel Area

Total nonfarm employment increased by +325 compared to December 2021.

Employment gains were posted in Government (+200), Natural Resources and Mining (+50), Leisure and Hospitality (+50), Trade, Transportation and Utilities (+50), Information (+50), and Other Services (+25).

No changes were reported in Construction, Financial Activities or Professional and Business Services. Payrolls decreased in Manufacturing (-75), and Education and Health Services (-25).

Jonathan Squire contacted the Wayne County WADI office to see if he might be able to receive some help with college from the Workforce Innovation & Opportunity Act (WIOA) Program. Jonathan knew he wanted to take classes to become a Diesel Equipment Technician at Wabash Valley College. Along with the cost of the tuition, books, lab fees and other supplies needed for the classes, he knew there would be one more very big expense, and that was tools!

Since Jonathan had just graduated from high school, he was not employed and was interested in the Work Experience Program also offered by WIOA. Jonathan was placed at Charles H. Carter & Son Trucking, Inc. in Fairfield for Work Experience. He was able to earn a salary, paid by the WIOA Program, while learning and being able to work on diesel equipment. Working hands on with the equipment at Carter's gave Jonathan a better understanding of what the instructor was teaching in the classroom.

Jonathan was able to keep his grades up, turning in only A's and B's every semester. He was also able to do more Work Experience as one of the required courses was Supervised Work Experience. He was placed at William J. Hodgson Trucking, Inc. in Crossville, for the time he needed to fill his class requirement. He always received very good reports on all the work that he had done, his punctuality, and for being easy to work with.

Jonathan has received several certificates for different achievements. Some are from MACS, Snap-On, Bendix, Conmet and Cummins, just to name a few. Jonathan is in his final semester of classes and will graduate in May 2023 with his Associate in Applied Science Degree/ Diesel Equipment Technology from Wabash Valley College in Mt. Carmel, IL. He has a very bright future ahead of him and has made his Career Planner very proud!
