#### **Success Story**

Anthony Jones lives in Grand Chain with his wife and teenage son. He had worked as a mechanic welder at Electric Energy, Inc. (EEI) in Joppa for 14 years when the plant shut down and laid off its employees in September of 2022. He needed a fresh start in his career and decided to contact Shawnee Development Council's WIOA program to see what was available.

When he came into the office, he said he was interested in the truck driving training course through Shawnee Community College in Ullin. After some discussion, testing, and paperwork, he began that journey in the fall of 2022. He obtained his Certified Drivers License in December 2022. Anthony looked at this accomplishment as preparation for his future with the IUOE Local 318 Union in Marion and applied for their heavy equipment operator apprenticeship program in May of 2023.

As a member of the union and part of his apprenticeship, Anthony is sent to work sites until he either gets laid off or the job ends. The union then sends him to another location. He has worked with E.T. Simonds, C.J. Mayhan Construction, Aldridge Electric, and is currently employed with Cupertino Electric helping to install electricity for a solar plant around Carmi, IL. Along the way, he has honed his skills and gained useful experience from each job. He said the apprenticeship program lasts 4 years and that he has insurance and a pension plan through the union.

Anthony's advice for anyone who gets laid off from their job is to not give up. Push yourself towards achieving your goals and believe in yourself.

#### **SDC MONTHLY UPDATE**

Currently, SDC has 4 participants on the QUEST WEX grant with one in each of the following counties, Johnson, Hardin, Union, and Massac. SDC also has one participant in an OJT as well. In September WIOA employees participated in several training opportunities including the LIHEAP annual training and the interagency meeting. In October, WIOA employees attended the Vienna High School Regional Summit, the Southern 14 quarterly inservice, the Business Services Team Meeting, as well as the annual fall retreat.

#### **SOUTHERN 14 UPDATES**

In 2025 IWDS will be replaced with IWDS 2.0 in Illinois WorkNet. Jessica has been working with the IWDS Transition Discovery Team on the Referral System section of IWDS 2.0. She says this work group is collaborating and giving great input to make the product something the career planners will find very user friendly. This month we held our quarterly in-service for both service providers with topics on monitoring, follow up, exit, service lines, and performance. We also will host our annual retreat. This year it will be held at Frontier Community College with the help of Business and Industry representatives. We have scheduled sessions that include ergonomics, ADA compliance, performance, Excel, and of course a fun activity that includes an escape room! This month Pam has completed an additional three county board meetings as well. The IWP had their annual training.
