Notes from the Office....

I am really tired of starting each newsletter with less than positive budget news. However, according to a conference call with IWP fiscal folks and DCEO we may know our funding level for PY13 by the end of March, but, DCEO cautioned that sequestration is still a possibility. In an attempt to prepare our area for the possibility of a decrease in funding levels I have provided each service provider with a mock budget based on a 10% across the board reduction and have asked that they put together a budget based on those allocations, including how they will meet the 40 % training minimum and an estimate of

how many clients will be served. As for the board office, Kim and I have been looking at our budget and will be producing a mock admin budget as well.

Also in the conference call, the question of failure to meet the 40/60 requirement was brought up. Apparently the first year an area fails to meet this benchmark the area become ineligible for incentive funds. This is not a real threat since no incentive funds are available. However, failing to meet the requirement for two years places the area on high risk status and may make the area ineligible for other grants such as IE.

The National Workforce Association reported to the IWP membership that Democratic Representatives in the House plan to reintroduce their 2012 WIA reauthorization bill this week and that the Republican Representatives are also retooling their proposed bill as well. Both parties are working to create a bipartisan support and are optimistic that the reauthorization will actually get accomplished this year. So I guess the threat of reauthorization continues to be an issue to watch. NWA also cautioned that the sequester is still likely to occur on March I as the continuing resolution expires March 27th. The level of sequester is not known since the negotiations of final fiscal year 2013 spending will restore some, but not all of the necessary cuts. NWA ended their newsletter with the statement "Upcoming 7 weeks are critical of WIA funding and reauthorization." With this in mind I would like to encourage each of you to reach out to your congress person to letting them know the value of the WIA in our area of Southern Illinois.

Notes from the Office....

Attention

Effective 1/1/2013 the GSA has increased the mileage reimbursement rate from \$0.555 to \$0.565. At the end of December 2012, the area had a training expenditure of 52% for the adult category and 39% for the dislocated worker category. WADI had a training expenditure of 28% for the adult category and 51% for the dislocated worker category. Mid 5 had a training expenditure of 48% for the adult category and 28% for the dislocated worker category. SDC had a training expenditure of 87% for the adult category and 42% for the dislocated worker category. Since these figures do not reflect the spring semester expenses, I anticipate the training expenditures to increase for both adult and dislocated worker.

DCEO announced that they will be combining the fiscal and programmatic monitoring this year. This change prompted me to look at some of our local policies, especially those that deal directly with client services. We plan to bring these changes to the programmatic / finance committee and hopefully to the full board at the March meeting.

For the last few months I have been reporting on the progress of a IE grant to serve the displaced coal miners from the Willow Lake Mine and American Coal. I am happy to report that we have that grant in place and currently have 25 clients enrolled in training and an additional 5 prepared to start soon. On a positive note we have had 2 individuals already exited because they found employment. This grant came with a small (5% of expenditures) admin component, but no provision for case management funding. As we do with Trade grants will be splitting the 5% with the service providers to help offset their expenses. If the funds are spent as projected the board office will have an additional \$2,300.



Also, still in the works is the joint venture with Man-Tra-Con to provide the training and services to those individual that were involved in the IE tornado cleanup project. As you may remember these individuals were paid for work experience then were eligible for training and related WIA services. Man-Tra-Con will be contracting with the Board and we in turn will be contracting with Mid 5 to provide the direct client services. This grant comes with a small amount of case management funding which will be utilized by Mid 5, but no administrative funding.

Kim, Ronda and I recently attended a bidder's conference to learn about a new grant opportunity with DCEO. The object of this grant is to decrease unemployment by helping business to avoid layoffs and unemployed workers re-enter the workforce. It could be used to provide incumbent worker training as a means of layoff aversion, on the job training for dislocated workers to bridge a skill gap, as well as class size or customized training. Each of these options has specific guidelines and employer contributions, but it maybe something that we can make work for our area. We are working with each of the service providers to brainstorm ideas. Please let me know if you know of a business that may be able to take advantage of this opportunity. It does have a submission deadline of March 15.

I am somewhat hopeful that the addition of these new granting opportunities may be enough to somewhat subsidize our budgets enough to enable us to continue business for another fiscal year.

Effective 1/1/2013 the GSA has increased the mileage reimbursement rate from \$0.555 to \$0.565. It is my plan to finally begin to visit each of the County Chief Elected Officials or their designees this month. I would like to meet with each one and give them a packet of information so that they are better informed. I have started this process by attending last month's Hamilton County Board meeting with Chris Howton.

We are still in need of some business members to serve on our board. We have sent letters requesting assistance from the CEOs as well as the local chambers. Please let me know if you are aware of any business person that might be interested in serving on our board.

SIC Adult Education and Literacy Area Planning Council Advisory Meeting was interesting this month. As was anticipated GED testing has been and will continue to be undergoing some big changes. One of the most concerning is the drastic price increase and while WIA can pay for those individual that are enrolled in our program, that still leaves a large pool of individuals in need of assistance. If you, your business, or any organization that you are involved with is interested in sponsoring a GED student please give Lori Cox a call (618) 252-4192. Lori also spoke about the new evidence based reading intuitive that places more emphases on reading with GED students as well as a mandated, yet unfunded, bridge program. This new program is designed to give GED students some additional soft skills and introduce them to opportunities in industries, such as health care. Its goal is to encourage them to see GED as a beginning, a step to more rather than an end.



I am continuing to work with DCEO and IDES to present the Small Business Workshops in our area. These workshops are designed to give business persons information not only about unemployment issues, but also available tax credits and grants, information available on Illinois WorkNet and other valuable information. We plan to offer at least two more of these workshops in Area 26 - one to be scheduled in Mt. Carmel and another to be scheduled at Shawnee College. I would like to encourage each of you to try to attend and help me spread the word to other business people. As soon as the details have been worked out I will let you know.

I did have the opportunity to be on the Morning with the Mayor Radio show on the Harrisburg radio station to make the public aware of the workshop as well as Southern I4 Workforce Investment Board and WIA. I can now add television, radio and newspaper to my resume.

Effective 1/1/2013 the GSA has increased the mileage reimbursement rate from \$0.555 to \$0.565. DCEO hosted a meeting with local college representatives, both local workforce areas and representatives from the new White Oak mine in Hamilton County that is scheduled to begin operations in early April. The meeting was mainly to discuss future as well as immediate training needs. The mine plans to hire 300 employees many of which they expect to have no previous mining experience as well as support staff in maintenance and administrative. Mid 5 staff and I plan to meet directly with White Oak to see if we can offer any OJT or other training through the new grant opportunity that I mentioned earlier.

Mike Woley invited me to speak to the McLeansboro Rotary this past Tuesday. Through this speaking opportunity I was able to make contact with three businesses interested in our services, one of which was the White Oak Mining Company. I plan to follow up with each within in the next week.

Kim and I have created a brief (10 - 15 minutes) PowerPoint presentation so we are ready - just let us know if you have an organization that might be interested in learning more about us.

Southern Illinois Highlights

Labor market conditions gradually improved throughout Southern Illinois during 2012. Several layoff events occurred at the end of the year in the region. In December, 10 counties report higher unemployment rates, 10 lower, and one unchanged. The data is not seasonally adjusted.

Retailers and restaurants employed temporary and part-time workers for the holiday season. Over the year employment increases were reported in Transportation, Financial Activities, and Professional-Business Services. Seasonal layoffs occurred in Construction and Recreation in late fall 2012. In the last quarter of 2012, several significant Manufacturing and Mining layoffs occurred in Southern Illinois. Employment opportunities were available in Healthcare and

Medical Support, Sales, Food Service, Transportation, Office and Administrative Support, and Installation, Maintenance and Repair. A number of employment openings also were in Business and Finance, Engineering, and Production such as welders and machinists.

The unemployment rate identifies those who are out of work and seeking employment. A person who exhausts benefits, or is ineligible, still will be reflected in the unemployment rate if they actively seek work.

Illinois has added +167,000 private sector jobs since January 2010 when job growth returned to Illinois following nearly two years of monthly declines. State data is seasonally adjusted. Since January 2010, leading growth sectors in Illinois are Professional and

Business Services (+79,500); Educational and Health Services (+43,600) and Manufacturing (+39,800). Government has lost the most jobs since January 2010, down -30,700.

The IDES supports economic stability by administering unemployment benefits, collecting business contributions to fund those benefits, connecting employers with qualified job seekers, and providing economic information to assist career planning and economic development. It does so through nearly 45 offices, including Illinois workNet centers.

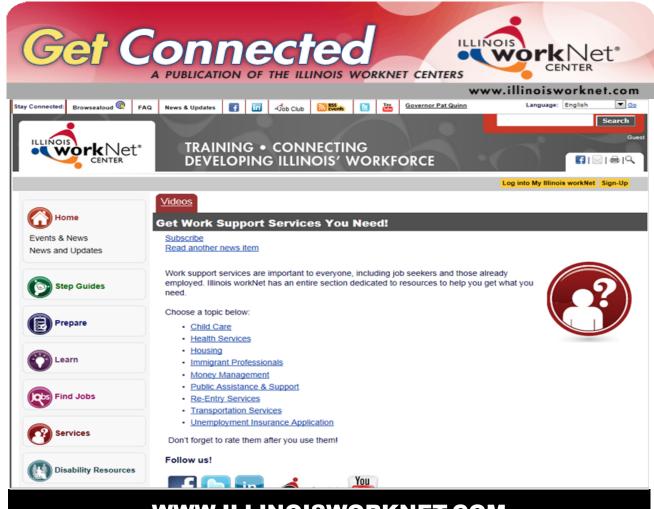
