WADI MONTHLY UPDATE

WADI has 15 students on track to graduate this spring semester including 10 nursing students, 2 criminal justice students, 1 diesel tech student, 1 early childhood student, and 1 business management certificate student. One participant completed his CDL training this month and obtained his Class A licence. WADI began a WEX participant for Bryan Tomms Farms in Carmi, WADI Hamilton County, as well as WADI Wayne County. A new WEX will begin this week at MotoRad in Mt. Carmel. Ryan Douthitt attended the SIC Kids Fair on March 26th. The SIC Job Fair was also held on April 16th with Ryan Douthitt representing WIOA as well.

SDC MONTHLY UPDATE

SDC has added three new truck drivers at Shawnee College.. Currently SDC has 1 WEX participant on the Quest grant in Pulaski and two WEX participants on the State grant with one in Pulaski and the other is Alexander. SDC also has four Youth WEX participants in Pope, Pulaski, Alexander, and Hardin. In March, SDC attended two IWDS 2.0 trainings. On March 27th the WIB office came and did their quarterly monitoring. In April, SDC attended four trainings for the new Service Matrix. They also attended the SCC job fair, the Southern 14 quarterly In-Service and the quarterly CDL updates. In May is the WIOA annual summit which will be in Peoria. SDC is currently down one career planner so they are working to hire temporary help until their return.

SOUTHERN 14 UPDATES

We received our official performance results for PY23. Performance results are based on 15 different measures which include Employment Rate 2nd Quarter After Exit, Employment Rate 4th Quarter After Exit, Median Earnings 2nd Quarter After Exit, Credential Attainment Rate, and Measurable Skill Gains for the Adult, Dislocated Workers, and Youth programs. LWIA 26 exceeded 12 and met 3 of the 15 measures, which is an amazing feat! Congratulation to the hard work of all our Title 1 staff for your continued efforts in getting participants back to work! We would also like to recognize that LWIA 26 was the TOP PERFORMER out of all 22 state workforce areas in the Employment Rate 2nd Quarter after Exit measure. We also were the second place performer in the total Youth program and third place performer for the total Adult program for the entire state!

Several new programs are being requested to be added to the approved trainings list. This is also a Board Recertification Year! As board members, you will be receiving updated Appointment forms that require your signature so be on the lookout for those!

Southern Illinois Highlights

Carbondale Area

Total nonfarm payrolls increased by +1,325 jobs in February 2025, compared to February 2024.

Employment rose among Private Education-Health Services (+575), Government (+425), Leisure-Hospitality (+225), Construction (+125) and Natural Resources-Mining (+25) employers.

No change was recorded in payrolls in the Trade-Transportation-Utilities, Information, Manufacturing and Professional-Business Services sectors year-over-year.

Employment declined among employers in Other Services (-25) and Financial Activities (-25).

Harrisburg Area

Total nonfarm payrolls decreased by -250 jobs in February 2025, compared to February 2024.

Employment rose among Private Education-Health Services (+125), Natural Resources-Mining (+50), Professional-Business Services (+25), Construction (+25) and Trade-Transportation-Utilities (+25) employers.

Employment declined among employers in Government (-200), Leisure-Hospitality (-125), Other Services (-75), Manufacturing (-25), Information (-25) and Financial Activities (-25).

Olney - Mt. Carmel Area

Total nonfarm payrolls decreased by -350 jobs in February 2025, compared to February 2024.

Employment rose among Private Education-Health Services (+75) and Manufacturing (+25) employers.

No change was recorded in payrolls in the Information sector.

Employment declined among employers in Leisure-Hospitality (-125), Trade-Transportation-Utilities (-75), Financial Activities (-50), Construction (-50), Natural Resources-Mining (-50), Other Services (-50), Government (-50) and Professional-Business Services (-25).
