WADI MONTHLY UPDATE

WADI had one work experience complete their training and were retained for employment. This was at the Victorian on Main in Fairfield. WADI has 21 participants in traditional classroom training. Half of those students are nursing students. 16 students will graduate this spring, 2 students will graduate in the summer and 3 will graduate in December! In January, WADI WIOA employees attended the Southern 14 In–Service where they were trained in case notes, the service matrix, worked with some hands on learning material in IWDS, instructed on performance outcomes, as well as were a part of the discussion on the area findings from their annual monitoring event.


SDC MONTHLY UPDATE

Shawnee Community College started on January 13th and Southeastern Illinois College started on the 14th. SDC has 15 new students enrolled in classes at these locations. In March, the CNA program and Truck Driving program will begin so several more students will be enrolled then. Currently, SDC has two Work Experience enrolled. One WEX is on the Quest grant while the other is Youth Out of School WIOA. They have 4 students getting ready to begin WEX as well. The state grant is now available so they are looking to begin an additional 4 students as soon as possible. In January, WIOA staff attended several trainings including a state webinar over childcare, SO 14 In-Service, BST meeting, Arrowleaf Advisory meeting, and the SDC safety meeting.

SOUTHERN 14 UPDATES

The Workforce Innovation and Opportunity Act requires that the local workforce board maintain a majority of their membership from the private business community. Our area has several open seats in multiple counties. If you live or work in one of our 14 counties and have any ideas on business leads please call our office! Our office has completed and sent in our monitoring response for DCEO. We feel very confident in our responses and got good feedback during our exit interview. Southern 14 and its MOU partners have completed the MOU revision and submitted our Report of Outcomes. This means that at the next board meeting you will see the MOU on the agenda for approval. In January, we completed an in person quarterly In-Service for our service providers. This took place at SIC where we worked on case notes as well as various other monitoring issues. Our quarterly Business Services Team (BST) Meeting met where Steven Dennis with IDHS presented material to the group regarding specific trainings he could provide to local area businesses. During this meeting members share upcoming events in our area. If anyone is ever interested in joining our BST please reach out and I would be happy to add you to our meeting!

Southern Illinois Highlights

Carbondale - Marion Area

The December 2024 unemployment rate was 3.7 percent, a decrease from the December 2023 unemployment rate of 4.1 percent. Employers in the region added +1,100 jobs year-over-year, including an increase in Government (+200) payrolls.

Surrounding Counties

Total nonfarm employment decreased by -50 jobs in December 2024 as compared to a year earlier.

Employers in the Leisure-Hospitality (+75), Manufacturing (+75) and Other Services (+25) sectors added jobs during the year.

No change in total employment was reported by employers in the Natural Resources-Mining, Information or Government sectors year-over-year. Payrolls decreased year-over-year in the Trade-Transportation-Utilities (-100), Private Education-Health Services (-75), Professional-Business Services (-50), Construction (-25) and Financial Activities (-25) sectors.

Harrisburg Area

Total nonfarm employment increased by +275 jobs in December 2024 compared to December 2023.

Employment gains were posted by employers in the Private Education-Health Services (+200), Government (+150), Financial Activities (+25), Information (+25), Natural Resources-Mining (+25) and Manufacturing (+25) sectors.

No change was recorded in payrolls in the Professional-Business Services sector. Employment declined among employers in the Trade-Transportation-Utilities (-75), Construction (-50), Leisure-Hospitality (-25) and Other Services (-25) sectors.

Olney - Mt. Carmel Area

Total nonfarm payrolls increased by +150 positions between December 2023 and December 2024.

Payrolls increased among employers in the Private Education-Health Services (+100), Government (+75), Other Services (+50), Natural Resources-Mining (+25) and Professional-Business Services (+25) sectors year-over-year.

Payroll employment was unchanged for employers in the Trade-Transportation-Utilities, Leisure-Hospitality and Manufacturing sectors. Employers in the Construction (-25), Information (-25) and Financial Activities (-25) sectors shed jobs between December 2023 and December 2024.
